 - (d) The institution shall comply with the various other norms and standards as prescribed in he NCTE Regulations.
 - (e) Non compliance of above conditions as mentioned vide this Order of Recognition shall invite action under Section 17(1) of NCTE Act, 1993.
 - 4. The Recognition is subject to the condition that he affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Departmen as per the norms of the NCTE / UGC / Affiliating University.

The institution shall submit to the Regional Committee' a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act. Rules, Regulations and/or order made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993.
